The largest bank failure since the Great Financial Crisis is likely to serve as a reminder to most depositories that funding concentrations and excessive interest rate risk can impact earnings, capital, liquidity, and ultimately solvency.

Aggressive Fed rate hikes and still strong loan

demand have resulted in a significant swing in liquidity positions for many financial institutions. The spike in short-term rates and inversion in the yield curve have contributed to rising cost of funds and net interest margin pressures. Loan demand funded by security sales, borrowings and other wholesale funding sources is impacting interest rate risk profiles, wholesale funding concentrations and capital ratios. During this session, we will review the best practices for managing interest rate risk and liquidity, and discuss current strategies community banks are utilizing to manage these pressure points.

Multiple factors have contributed to current challenges in Florida's property insurance market including catastrophic hurricanes, insurance claims litigation and fraud. Rates have risen astronomically in recent years and experts report Floridians are paying three times the national average raising concerns for both property owners and bankers. Due to the state's high risk, many insurance companies have exited the Florida market leaving Floridians with fewer choices and rising rates. Panelists from the Office of Insurance Regulation, Citizens Property Insurance and Zurich, N.A., along with moderator McHenry Kane, City National Bank's General Counsel, will discuss this challenging issue, its impact on Florida financial institutions and possible options for the future.
